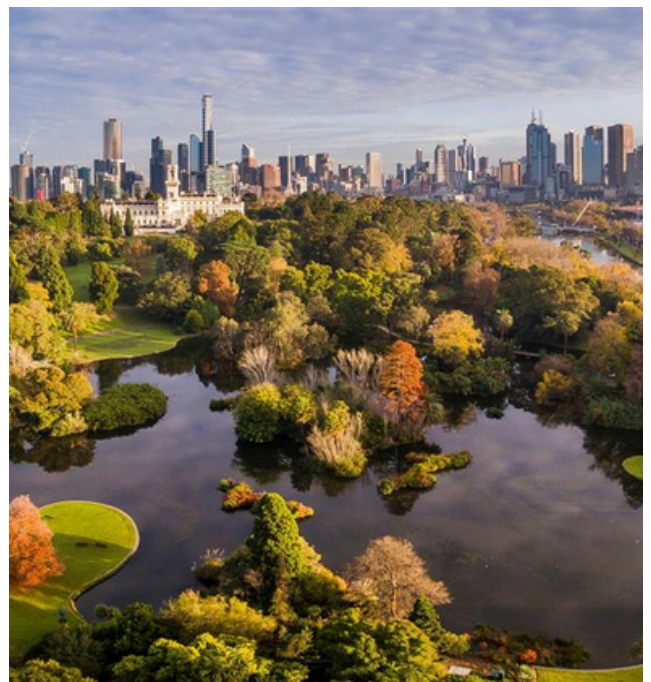

A CHANCE TO STUDY AND LIVE IN INTERNATIONAL ENVIRONMENT

This year, the **BBA** Program will grant 1 scholarship for 3rd year student who achieve the GPA of 3.00 or above. Students will be partly financially supported to study at the **MONASH University, Melbourne, Australia** for one semester and the credits will be transferred back to PSU.

Each student participating in the exchange program shall meet the full- costs related to:

- 1.Travel documents and visas
- 2.Travel to and from the host country
- 3.Living and subsistence expenses as an exchange student
- 4.Accommodation fees and charges at the HOST institution
- 5.Application or related fees as may be charged by the HOST institution
- 6.The cost of health insurance at the HOST INSTITUTION and HOST country and Vaccinations (if required)
- 7.Normal non-tuition course related fees, including but not limited to: Book and academic supplies, study materials costs, field trip and excursion fees etc.
- 8.All other debts, fines or financial penalties incurred during the course of the EXCHANGE
- 9.Application and regular tuition fees as are normally charged to the student for taking courses at the HOME INSTITUTION - these fees are to be paid to the HOME INSTITUTION

Remarks: The nominated students must also pass the MONASH University selection process to be granted this scholarship
