STAY EXTENSION

A member who wishes to extend their stay permission can apply for stay extension at the provincial immigration office located in the member's residence area. The imigration officer shall extend the stay permission according to the member's visa. The fee is THB1,900 and it is possible to apply for an extension 30 days in advance.

Thailand Privilege Members can extend their stay permission at the immigration office in the area of your residence. Members will be required to be present at the immigration office to take a picture and a fingerprint scan in front of the immigration officer.

90-DAY REPORT

Staying in Thailand for a period longer than 90 consecutive days, a member is required to report himself at the immigration office located in the member's residence area. Failure to file 90-day report can result in a fine of THB 2,000. The member can file this report within 15 days before or 7 days after 90-day period expires.

Thailand Privilege Members are required to do the 90-day report if staying in Thailand continuously without leaving the country for over 90 days.



REQUIREMENTS FOR MEMBER

 - Front page showing name / surname / passport number Current PE visa
 - Latest entry stamp and all extension stamp in the latest visit (if any)
- 3) 2 Inches (or 4x6 cm) photos (2 photos)
- 4) Departure Card (TM6)
- 5) Thailand Privilege Membership Card
- 6) TM30 Receipt
- 7) Filled TM7 form (available at all immigration offices)
- 8) Extension fee of 1,900 Baht per person to be paid to immigration officer in cash only

WHAT IS OVERSTAYING?

Overstaying is when a foreigner lives in Thailand for a period exceeding the length of time they are permitted to stay, according to their visa and entry stamp.

If you have a very long overstay record and turn yourself in to the authorities, you will have to go before a judge in court.

Keep in mind that this includes overstay fine as well!

*It is a foreigner's responsibility to check and ensure that he/she does not overstay.

CONSEQUENCES OF OVERSTAYING YOUR THAI VISA

Please note that repeated violations of overstaying can hold serious consequences. In the event that you have had a few overstays, your passport could be stamped with a stamp declaring you in violation of the immigration laws and regulations of Thailand. This stamp will label you as an "undesirable alien", which could make travel and obtaining entry to other countries much harder than it should be.

You also could be held in the Immigration Detention Center until you have arrange the ticket on a direct flight back to your own country. You will then have to pay a small fee to the immigration officers to take you to the airport and accompany you through Immigration, where you will get the blacklist stamp in your passport, and

to the gate. Your passport will be given to one of the cabin crew on the flight and they will return to you when you arrive in your home country.

PEVISA

Members on a Privilege Entry Visa will be granted a 1-year extension for each application.



According to the Immigration Bureau, the following are the advisable and required practice and regulations to be complied with by foreigners seeking a stay in the Kingdom of Thailand.

- 1. Once arrived in the Kingdom of Thailand, a foreigner shall not stay in the Kingdom longer than the period of a stay permit.
- 2. A foreigner who overstayed in the Kingdom of Thailand before the order's date of enforcement of March 20th, B.E. 2559 (2016) can surrender to the authorities at the immigration checkpoints before being allowed to leave the Kingdom and pays a fine of 500/day, but not exceeding 20,000 baht.
- 3. In the event that a foreigner overstayed in the Kingdom of Thailand and failed to leave the country before the order's date of enforcement of March 20th, B.E. 2559 (2016), the foreigner will face a fine of 500 baht/day, but not exceeding 20,000 baht, and will be banned from re-entering the Kingdom of Thailand for the respective period as follows.

IN CASE OF ALIENS SURRENDERING TO THE AUTHORITIES

Period of Overstay	Perid of banning from re-entering Thailand
More than 90 days	1 year
More than 1 year	3 year
More than 3 year	5 year
More than 5 year	10 year

IN GASE OF ALIENS BEING ARRESTED AND PROSECUTED

Period of Overstay	Perid of banning from re-entering Thailand
Less than 1 year	5 year
More than 1 year	10 year

REMARK

The prohibition of entry starts from the day alien departs from the country.

This rule does not apply to:

- 1. An alien who departs the country before he age of 18.
- 2. An alien who departs the country before enforcing this rule.
