

How many years have they run the devil's dirty plan?

(Rewrite of "How many years they ran the devil's dirty plan"
which was emailed Prince William on 23 January 2019)

Note: *I wrote this script while I was being deceived* "Will is trying his best to help You. He ordered his authorities to secretly investigate to find the truths out".

I would like to throw light on it again. In early 2019, I was being still tricked "Investigation is a way to solve the problems. So, Will will order his trustworthy authorities to investigate to prepare himself for declaring the truths."
