

## ***A very important report***

***(24 June 2023)***

***(I wrote these truths from 23 June 2023 to 24 June 2023, and posted them on My website for the first time on 24 June 2023. But I completed them again on 26 June 2023, and posted them on My website again on 27 June 2023.)***

This report is so very much important. So, please read all words of this report.

The Father Almighty told Me to throw light on this truth again in the middle of June 2023 “Kay, emphasize to foreign people “Pimp king Bhumibol and the satanic Chakri dynasty have planned to let Prayuth Jun-o-cha lead the Thai troop to lie to foreign people “I and the Thai troop have committed the devil’s dirty plan for a long time. And we are henchmen of Queen Elizabeth and The British Monarchy!””

Later on, Ratchaneewan Ad-harn and Ad-harn family allowed The Father Almighty to tell Me on 22 June 2023 at around 9:15 pm “High-level Thai soldiers have complained to one another “The story has gone on like this because king Bhumibol still has not ordered anyone to kill Ratchaneewan Ad-harn and Ad-harn family. Thus, Ratchaneewan and her family have allowed The God to tell Kay all our plans!” But pimp king Bhumibol has insisted to Prayuth Jun-o-cha and Prawit Wongsuwan who are middle men between pimp king Bhumibol and the high-level Thai soldiers “I want to alibi “We were controlled by Ratchaneewan Ad-harn, Ad-harn family, and their gangs!””

On the same day at around 9:20 pm, after I had started to wonder “Ratchaneewan Ad-harn and Ad-harn family have allowed The Father Almighty to tell Me all the plans of pimp king Bhumibol, the satanic Chakri dynasty, and high-level Thai soldiers. Why pimp king Bhumibol has not ordered anyone to kill them yet? What are their purposes to tell Me all their plans? Or I was fooled?”, I quickly figured out why pimp king Bhumibol has not ordered anyone to kill Ratchaneewan Ad-harn and Ad-harn family yet. The truths are;

Ratchaneewan Ad-harn has negotiated with pimp king Bhumibol and has requested him not to kill her and her family by reasoning ...

... “If you order your subordinates to kill me and my family, results will be;

1) Foreigners will believe Kay “The story and the plans Kay has told us are the truths” because the foreigners saw the death of me and my family. And

2) Foreigners who can reform themselves but they work the devil’s dirty plan with us will see “karmas”, so many of them will quit the plan.

But if you do not order anyone to kill me and my family, results will be;

1) You can alibi “The story and the plans Kay has told foreigners are the lies which some groups want to blacken us. And the groups are Queen Elizabeth, King Charles, Prince William, Prince Harry, The British Monarchy, all British people, and their foreign henchmen!”, so it will be an advantage for you to alibi and blacken Queen Elizabeth, King Charles, Prince William, Prince Harry, The British Monarchy, all British people, and other countries.

2) Foreigners who can reform themselves but they work the devil’s dirty plan with us still have not seen “karmas”, so they will not quit the plan. And

3) Because you will have appropriate alibis to blacken Queen Elizabeth, King Charles, Prince William, Prince Harry, The British Monarchy, all British people, and other countries to be sentenced instead of you, so you and your family will have more time to severely torment Kay, Her parents, and foreigners all over the world!

We promised that if you keep our lives, we will help you and your family to alibi by lying to foreigners including judges and juries in every court of law “We are henchmen of Queen Elizabeth and The British Monarchy to run the devil’s dirty plan to overthrow king Bhumibol and the Chakri dynasty!”

While I was writing drafts of the report, I usually heard “Did you see Kay could figure out?”

After I had figured out why Ratchaneewan Ad-harn and Ad-harn family have not been killed yet, “the voices” hardly were loud. I mean that “the voices” were quiet from around 8:30 pm to 10:30 pm, and I could not sleep until 23 June 2023 at around 2:00 am even though all day of 22 June 2023, I spent My time to walk and pull a wheelchair for My dad at Chulabhorn hospital. The Father Almighty told Me “Kay, “the voices” were quiet because they were stressfully and seriously consulting one another. And at that night, I heard the voice of prostitute princess Ubolratana Rajakanya “We want Kay to be shock” more than 3 times.

The Father Almighty told Me on 23 June 2023 at 7:02 pm “Pimp king Bhumibol consulted Prayuth Jun-o-cha and Prawit Wongsuwan about the negotiation Ratchaneewan Ad-harn negotiated with him. And Prayuth and Prawit agreed with pimp king Bhumibol not to kill Ratchaneewan Ad-harn and Ad-harn family because of the reasons Ratchaneewan reasoned pimp king Bhumibol. Prayuth and Prawit also advised pimp king Bhumibol “If you still have not ordered anyone to kill them, we can alibi by lying to foreigners, and judges and juries in every court of law “We were controlled by Ad-harn family and their gangs who are henchmen of Queen Elizabeth and The British Monarchy!”.

The Father Almighty also told Me “After some high-level Thai soldiers who have spent their time to follow Your thought to know what You heard, had complained to Prayuth Jun-o-cha “The story has gone on like this because king Bhumibol still has not ordered anyone to kill Ratchaneewan Ad-harn and Ad-harn family, so Ratchaneewan and her family told Kay all our plans!”, Prayuth told them “Let them tell Kay all our plans!” Then, Prayuth told the high-level Thai soldiers the negotiation between Ratchaneewan and pimp king Bhumibol, what are the agreements, and “We can alibi by lying to foreigners, and judges and juries in every court of law “We were controlled by Ad-harn family and their gangs who are henchmen of Queen Elizabeth and The British Monarchy!”. And the high-level Thai soldiers felt pleased with the agreements and the alibis.

I told you that pimp king Bhumibol and the satanic Chakri dynasty have planned to alibi and blacken Queen Elizabeth, King Charles, Prince William, Prince Harry, The British Monarchy, all British people, and other countries since the start. So, they have controlled King Charles not to let Prince William call Me to help Me before 24 July 2023. Because more time King Charles and Prince William wait, it will be the best for pimp king Bhumibol, the satanic Chakri dynasty, and all Thai people to alibi and blacken Queen Elizabeth, King Charles, Prince William, Prince Harry, The British Monarchy, all British people, and other countries. Whereas, The Father Almighty told Me from 23 June 2023 to 24 June 2023 “Kay, King Charles has heard many things different from the truths You knew!”

Pimp king Bhumibol and the satanic Chakri dynasty have helped one another to control King Charles not to let Prince William call Me before 24 July 2023 to help their attorneys to lie to foreigners including judges and juries in every court of law “Why Prince William did not fast call Kay after he had known the truths “We are fooled into waiting” during New Year 2023? Why Prince William called Kay after 7 months of 2023 had passed? It is because even Kay sometimes started to doubt “Or Prince William wants to kill Me?” So, Prince William, King Charles, Prince Harry, Queen Elizabeth, and The British Monarchy have been afraid that everyone will know who the real Satans and the real devils are!”

The Father Almighty told Me on 22 June 2023 after 10:30 pm “Although pimp king Bhumibol, the satanic Chakri dynasty, and all Thai people really know “Prince William was fooled by us “This is a test” and “Jesus is coming to judge the living and the dead soon” , and pimp king Bhumibol, the satanic Chakri dynasty, Kate, and Camilla ordered The God to control Prince William to “feel” that “I can bear to approach the wicked to complete my mission which is to test humans””, they will blacken Prince William by asking “Could you notice how many years Prince William spent his life with Kate? And what Prince William did for Rose? If Prince William was The Real Son of The God and The Real Soulmate of Kay, why he spent his life opposite to Kay? Why he can approach the wicked?””

The Father Almighty told Me to emphasize the truths again “Kay, stress these truths “All consultants of King Charles have worked together to deceive King Charles to wait for 7 months of 2023 will pass to make judges and juries in every court of law doubt “Who are real criminals?” to help pimp king Bhumibol, the satanic Chakri dynasty, David Cameron, and their own themselves not to be convicted of “terrorisms” and “genocide people all over the world”. In that one of the principles of criminal law is “A man will be convicted of a crime and/or a felony and will be sentenced by criminal law after a plaintiff and/or a state attorney can prove his crime and/or his felony **undoubtedly!**” For their evil work, the consultants who cannot reform themselves will lie to judges and juries in every court of law “We never advised King Charles to wait for anything. King Charles did by himself in that Queen Elizabeth, King Charles, Prince William, Prince Harry, and The British Monarchy are the leaders of the devil’s dirty plan!” And because of the words of the consultants who cannot reform themselves, so attorneys of pimp king Bhumibol and the satanic Chakri dynasty can alibi “The close subordinates of King Charles and The British Monarchy **themselves** spoke out!””

Pimp king Bhumibol, the satanic Chakri dynasty, all Thai people, and all evil foreign people will also blacken Prince William and The British Monarchy by lying “King Bhumibol was fooled “Jesus is coming to judge the living and the dead soon in that Prince William and The British Monarchy ordered The God to send their thoughts to trick King Bhumibol!”

The Father Almighty told Me “Joe Biden has applauded pimp king Bhumibol, the satanic Chakri dynasty, and high-level Thai soldiers “Your plans are profound!” All foreign henchmen of pimp king Bhumibol and the satanic Chakri dynasty still believe pimp king Bhumibol “These plans will help us not to be convicted of any crimes and any felonies we have committed altogether in that a principle of criminal law is that a man will be convicted of a crime and/or a felony and will be sentenced by criminal law after a plaintiff and/or a state attorney can prove his crimes and/or his felonies **undoubtedly!**”

Pimp king Bhumibol never discusses with many of his foreign henchmen “What will happen if we are sued by Sha-re-ah Law of the Muslim world!” and pimp king Bhumibol never points his foreign henchmen to see;

1) “A large number of Muslims who are victims of us will not definitely surrender to be tormented for free!”

2) “Kay is The Daughter of The Father Almighty. Prince William is The Son of The Father Almighty. And King Charles and Prince Harry are gods whom The Father Almighty sent to do the missions of The Father Almighty. But another name of The Father Almighty is “Allah”. As a result, although we will not be convicted of any crimes and any felonies by judges and juries in every court of law of Christian

countries, Kay, Prince William, King Charles, and Prince Harry have the full rights to proceed the court cases to Muslim courts in the Muslim world!”

3) “Sha-re-ah law of the Muslim courts in the Muslim world is religious law and uses a principle “An eye for an eye, a tooth for a tooth”. And

4) “After Kay and Prince William will have been at The Holy Home, Na-bee Mohammad who is The Greatest Prophet of Muslims will talk to every Muslim judge of the Muslim courts by himself. And because the Muslim courts are religious courts, so every Muslim judge will listen to “Allah” and “Na-bee Mohammad”!”

Anyway, because of their alibis to blacken Queen Elizabeth, King Charles, Prince William, Prince Harry, The British Monarchy, and all British people I told you earlier, so I strongly believe that after Prince William will have called Me, if I and My parents are still detained in Thailand, pimp king Bhumibol, the satanic Chakri dynasty, and all Thai people will continually torment Me and My parents violently more than from the end of November 1999 to a day when Prince William calls Me. In that they will lie to foreigners “Prince William and The British Monarchy severely torment Kay and Her parents speedily to succeed in the devil’s dirty plan!” I would like to stress the truths again. Because of this, pimp king Bhumibol, the satanic Chakri dynasty, and all Thai people will have more time to violently torment Me, My parents, and foreign people all over the world!

By the way, I would like you all to know many advantages of us if King Charles, Prince William, and Prince Harry fast fire Camilla, Kate, and Meghan out of their positions and the palaces, if King Charles quickly lets prince William call Me, and if King Charles, Prince William, and Prince Harry hurry declare the truths;

If King Charles, Prince William, and Prince Harry fast fire Camilla, Kate, and Meghan out of their positions and the palaces, it will be advantages for King Charles, Prince William, and Prince Harry in that;

1) King Charles, Prince William, and Prince Harry will not need to pretend to know nothing and maybe lie to other people which oppose to their natures.

2) King Charles, Prince William, and Prince Harry will not need to tolerate spending their lives with the prostitutes who are the devils. And

3) King Charles, Prince William, and Prince Harry can tell judges and juries in every court of law “After Kay had told us we have been fooled into waiting for so long by all consultants of King Charles by explaining the felonies they have committed altogether since 2000, we **adjusted** our plan to quickly help Kay, Her parents, and Her group.” King Charles can also tell the judges and the juries “I never love Camilla and never want to spend my life with her. I married her because I was controlled!” Prince William can also tell the judges, the juries, and Me “I never love Kate and never want to spend my life with her. I married her because I was ordered!” And Prince Harry can also tell the judges, the juries, and his soulmate “I never love Meghan and never want to spend My life with her. I married her because I was

ordered”, so it will be the big advantages for King Charles, Prince William, and Prince Harry to sue them for:

- The offenses against the King (King Charles), the Queen (Queen Elizabeth), and Heirs-apparent (Prince William and Prince Harry)

- Offences Against Life and Body
- Offences Causing Death
- Offences of Murdering the other person
- Offences of Murdering the other person by premeditation
- Offences Against Body
- Offences of Bodily Harm
- Offences of Grievous Bodily Harm
- Offences Against Liberty and Reputation

And

- Offences Against Property

I mean that if King Charles, Prince William, and Prince Harry fast fire Camilla, Kate, and Meghan out of their positions and the palaces, Camilla, Kate, and Meghan cannot excuse “We strongly believed “The king and the princes love us, and want to spend their lives with us!” or “The king and the princes complied with the orders!”

King Charles, Prince William, and Prince Harry never deeply studies criminal law, so they never know if attorneys of pimp king Bhumibol, the satanic Chakri dynasty, the consultants of King Charles, Camilla, Kate, Meghan, and David Cameron **can tempt** judges and juries in courts of law of England **into accepting** the excuses of Camilla, Kate, and Meghan earlier, we will be **“under dog”**.

However, I graduated from faculty of law, Thammasat University in 1997. At that time, Thammasat University was the number one of faculty of law in Thailand. And I got 90 scores from 100 scores for criminal law.

I really believe that because all consultants of King Charles want to tempt King Charles into waiting in that more time King Charles, Prince William, and Prince Harry wait, it will be the best for pimp king Bhumibol, the satanic Chakri dynasty, the consultants of King Charles, Camilla, Kate, Meghan, and David Cameron in courts of law, so the consultants discredited Me by not telling King Charles “Basic of criminal law of both civil law and common law are **the same!**” ...

If King Charles, Prince William, and Prince Harry have a chance to read this report and have read to this line, I would like to ask King Charles, Prince William, and Prince Harry “Could you remember I told you one of their plans is killing Kate and “her” children to blacken Prince William “Prince William himself ordered his henchmen to kill Kate and “her” children to everlastingly shut their mouths up in that Prince William and The British Monarchy do not want everyone to know “We are the leaders of the devil’s dirty plan!”?” So, could you all figure out if David Cameron and the consultants can tempt the judges and the juries in the courts of law of England into accepting the excuses of Camilla, Kate, and Meghan earlier, what will happen to our court cases? ...

... **The Father Almighty emphasized the truths to Me** on 26 June 2023 in the afternoon “Kay, **two of their main plans are that: 1) Just make Me cannot be a witness in every court of law. And 2) Just make judges and juries confuse “What the truths are and who the real criminals are!”** ...

... I would like to underline the truths again “A man will be convicted of a crime and/or a felony and will be sentenced by criminal law after a plaintiff and/or a state attorney can prove his crime and/or his felony **undoubtedly!**” and “Judges must judge a defendant **without** any biases!” ...

... Did you know although I love to learn languages the most, why The Father Almighty “put an emotion and a desire “I strongly want to study law”” on Me when I was a teenager? **The Father Almighty told Me “Kay, King Charles, Prince William, and Prince Harry studied other subjects, so You had to study law to help them to know “The consultants *fooled* us!” And “We *cannot* trust the consultants!”** ...

If Prince William quickly calls Me, some significant advantages are;

1) Prince William and Me can talk the truths to each other, so Prince William will know the truths which he still has not known from Me, I will know the truths which I still have not known from Prince William, and **we can consult each other, so Prince William, King Charles, and Prince Harry will know principles of laws from Me, and I will know real situations in the UK from Prince William.** As a result, **did you understand why pimp king Bhumibol, the satanic Chakri dynasty, all Thai people, and all evil foreign people *cannot* let Prince William fast call Me easily?** And

2) Prince William can dun Google for My all money which I have gotten from selling My first e-book on Google Play, and My latest book which is one of the best pieces of evidence will be supported to be published by King Charles, Prince William, and Prince Harry, so I will have full of confidence:



2.1) I have enough money for:

(a) Electricity cost. Therefore, I can turn on air-conditioning in My bedroom more than 20 hours a day 😊😊.

(b) I have enough money to move My parents to cure their diseases at Bumrungrad Hospital where is the leading international hospital in Thailand instead of curing their diseases at **Chulabhorn hospital** where belongs to **prostitute princess Chulabhorn Walailak who is the youngest child of pimp king Bhumibol and prostitute queen Sirikit**. I told Prince William many times **“My dad is an elderly, so he has had problems about joint bones of his legs. His doctor and My mom told him “If you do not fast surgery, you *cannot* walk soon!” But *My dad needs to wait for his queue to surgery at Chulabhorn hospital more than 1 year”***.

(c) I have enough money to move Myself to cure My diseases at Bumrungrad Hospital instead of curing My diseases at governmental hospitals **where pimp king Bhumibol and the satanic Chakri dynasty are *supporters***. And

(d) Living in lying and pretence make Me ***so very much stress***, so I really would like to know if Prince William calls Me, will pimp king Bhumibol and the satanic Chakri dynasty order other people to continue pretending to know nothing and lying to Me? ***If they still order other people to continue pretending to know nothing and lying to Me, at least, I will have Prince William as the only one person in the world who talks the truths to Me, so My stress will be reduced*** 😊😊.

Some important advantages of quick declaration the truths are;

1) From declaration day, pimp king Bhumibol, the satanic Chakri dynasty, all Thai people, and their all foreign henchmen who cannot reform themselves **cannot** decline **“We *do not* know who Kay is”** Because of that, it will be our advantage when we proceed our court cases to every court of law **especially** every Muslim court 😊😊.

2) I will have Prince William’s trustworthy people to help Me to do housework and look after My parents, so I will have more time to rest, to complete My latest book, and to shopping 😊😊.

Before I am finishing telling the truths in this report, I would like you to know that in early June 2023, once after I had thought **“Pimp king Bhumibol and the satanic Chakri dynasty have asked Thai merchants, Thai businessmen, and Thai commercial companies for cooperation to follow orders of pimp king Bhumibol and the satanic Chakri dynasty until Ratchaneewan Ad-harn and Ad-harn family will be killed. Therefore, pimp king Bhumibol, the satanic Chakri dynasty, and all Thai people can lie to foreigners “Ratchaneewan Ad-harn, Ad-harn family, and their gangs themselves ordered!”**, The Father Almighty told Me **“That’s right!”**



Last, I would like to talk to King Charles, Prince William, and Prince Harry ...

... “You all have **never** talked to Me and have **never** consulted Me. So, from the end of November **1999** to the end of **2016**, I **never** knew what you all were waiting for. However, after I had known “Good Christians are waiting for The Judgement of Jesus” in early 2017 and “You all and almost all foreigners especially “the white” have been under control” in the middle of 2018, I tried to tell you the truths I have known because **I was sent to be born as a Buddhist in Thailand**. I also tried to tell you the truths **The Father Almighty and the song “F\*\*k’in Perfect” sung by P!nk told Me ...**

... From the middle of 2017 to the end of 2022, I told you many times “Jesus will come to judge the living and the dead in 4457 AD”. And from the middle of 2018 to the end of 2022, I told you many times “You all have been **under control** not to follow My solution” I also asked you all to help you all to think “If you are not under control, why you all always break The Daughter’ hope?” And “What kind of people who always break The Daughter’s hope?” But you all **never** listened to Me. ...

... So that, you all **had** a very expensive lesson. However, now, I have told you **the solution** as I graduated bachelor degree from faculty of **law**, Thammasat University, **the number one** of faculty of law in Thailand before 2000, and I got **90 scores from 100 scores** for criminal law. **Why you all cannot be reminded of the very expensive lesson by the very expensive lesson and make a big mistake again? ...**

... You all were sent from Daddy Almighty to be **My very important backup**, so I truly believe that you all **are not** idiotic. Therefore, think twice: **Have you all been under control not to follow My solution? ...**

... His Majesty The King, sir. His Majesty The King gave the time to the investigation team and His Majesty The King always think “I cannot take my words back!” ...

... His Majesty The King, sir. When you were a boy, home telephones are so modern. But today is 2023 and mobile phones are so normal. So that, to continue being alive, the old generation needs to **“adjust”** themselves. I mean that **to save the thrones, you need to adjust yourself and The British Monarchy to be “up to date”**. ...

... Maybe rude, but the truths are that “Dinosaurs” that were normal in the past cannot be alive until today. “Kodak” is also. But why “Pepsi” “Unilever” and “Marks and Spencer” can run their businesses until today? It is because they **usually adjust** their products to be **“trendy”**, right? ...

... So that, His Majesty The King, sir. Why do you always think “I cannot take my words back” His Majesty The King, sir. **Soldiers know “If a way we use to fight against our enemies cannot help us to win, we need to adjust “our strategy”**” ...

... His Majesty The King, sir. You, Prince William, and Prince Harry are soldiers and His Majesty The King are not a dinosaur. So, **why do not you look our problems by “the soldiers’ perspective”?** Just **adjust** the plan and let Prince William fast call Me to talk the truths to Me, **to consult Me**, and to help Me and My parents. ...

... His Majesty The King, sir. His Majesty The King, Prince William, and Prince Harry have pretended to know nothing, and maybe have lied to other people. And His Majesty The King, sir. What behaviours of His Majesty The King, Prince William, and Prince Harry have been since the end of November 1999? So, if attorneys of pimp king Bhumibol and the satanic Chakri dynasty **discredit** you all in courts of law of England “The words of King Charles, Prince William, and Prince Harry **cannot** be trusted in that they have **usually** pretended to know nothing and have **usually** laid to other people!”, what will you all answer the judges and the juries? ...

... His Majesty The King, sir. If His Majesty The King answer the judges and the juries “I am The King of The United Kingdom. And Prince William and Prince Harry are heirs apparent of The British Monarchy.”, **what statuses of pimp king Bhumibol and the satanic Chakri dynasty are? ... His Majesty The King, sir. Because you all have let Me be detained in Thailand since the end of November 1999, so My parents have needed to dramatize and lie to Me too. His Majesty The King, sir. Even The Father Almighty has been ordered to send their thoughts to lie to foreigners. So, His Majesty The King, sir. **Now, I am the only one in the world who have never laid to anyone since I was born! ...**

And His Majesty The King, sir. **I would like to spotlight a truth again “A man will be convicted of a crime and/or a felony and will be sentenced by criminal law after a plaintiff and/or a state attorney can prove his crime and/or his felony *undoubtedly!*” And “Judges must judge a defendant *without* any biases!” ...**

... His Majesty The King, sir. Could you figure out that the way which the consultants have advised you and the way which your English authorities have used to find the truths and evidence are **a consequential way to *discredit* and *blacken* you, Prince William, Prince Harry, and The British Monarchy in every court of law but are a consequential way to help pimp king Bhumibol, the satanic Chakri dynasty, the consultants, David Cameron, Camilla, Kate, and Meghan *not to* be convicted of any crimes and any felonies they have committed altogether?**

... His Majesty The King, sir. Could you remember I asked you “If you all **do the right**, but your English authorities **cannot** find the truths and any evidences to prove their crimes and their felonies **after** they have run the devil’s dirty plan for **more than 20 years, why your government needs to waste the state budget to hire the English authorities?” ...**

... His Majesty The King, sir. The truths are that “Pimp king Bhumibol, the satanic Chakri dynasty, and high-level Thai soldiers have run the devil’s dirty plan since before 1960” “Marilyn Monroe was murdered in 1962” “JFK was assassinated successfully in 1963” “Princess Diana’s heart had been so much hurt before the engagement day would come.
