

## ***My message to King Charles III of The British Monarchy (20 March 2023)***

I would like to send My message in this video clip to King Charles III of The British Monarchy.

His Majesty The King, sir. If now you knew the truths and are waiting for result of investigation, I have many newly crucial truths to tell you.

His Majesty The King, sir. I would like to spotlight the truths again. We, many British people, and immense foreign people have been violently tormented since the end of November 1999 as His Majesty The King, Prince William, and Prince Harry have been controlled to believe in yourselves more than believe Me, right? So, why today His Majesty The King, Prince William, and Prince Harry have surrendered to be controlled to believe the investigation team more than believe Me again?

His Majesty The King, sir. I believe that the investigation team has tempted you into waiting for much evidence by fooling you “Judges will judge them by consideration what else are their orders, what else are their behaviours, and what else are evidences” His Majesty The King, sir. Please listen to Me and carefully consider again;

His Majesty The King, sir. Pimp king Bhumibol and the satanic Chakri dynasty have had the time to destroy all evidences since the end of November 1999. Could His Majesty The King notice many creative people who knew the truths such as Amy Winehouse, Michael Jackson, Whitney Houston, and Chester Bennington were passed over?
