

Other advices apart from the advices in the 2 previous topics (6 January 2024)

Before all else, I would like My Real Soulmate to know that I am not sure “Request a judge to order something to have a legal result” is called “plea” or “petition” but in this document, I am calling it “plea”. And I would like My Real Soulmate to know;

For Thai criminal law;

To request a judge to order something to have a legal result, a person just writes “a plea form” to proceed his request to the judge without reporting anything to a police officer to investigate. So, the person just prepares many things he can find to attach the plea form to help the judge to allow to be as the plea. And he can proceed the plea form to court of law by himself or authorise an attorney to run the process instead of him.

But to sue another person who offended him, he who is a victim has both 2 ways to proceed his case:

(1) Report his case to a police officer, and proceed his case to court of law by himself. And

(2) Report his case to a police officer to investigate. Next, the police officer reports result of investigation to a state attorney to help the state attorney to have an opinion “sue” or “not sue”. If the state attorney has an opinion “sue”, the state attorney will run process to sue the defendant, and he who is the victim can request the state attorney to be a co-plaintiff.

I believe that criminal law of your country and criminal law of My country are similar. So, to request a judge to order “The marriage of I and the harlot is void”, you do not need any results of investigation. Just write a plea form and attach many things I advised you in the topic “How to request a judge in your country to order “The marriage of I and the harlot is void” without investigation (5 January 2024)” to the plea to proceed your plea to court of law. And the judge will “investigate” at court of law to allow to be as the plea or not to allow to be as the plea 😊😊.

I would like you to know that because while I was writing the topics “How to request a judge in your country to order “The marriage of I and the harlot is void” without investigation (5 January 2024)” and “The truths your attorneys have to point a judge to see (6 January 2024)”, I did not separate “how to plea” from “how to sue”. Whereas, ***the order of a judge to allow to be as the plea or not to allow to be as the plea results to our sues (or another word is “our court cases”)***.

Therefore, ***the vital points are that your attorneys must point the judge to allow to be as the plea, and a reason to allow to be as the plea must be “The woman whom you married is a harlot” to be noted in a judgement of court of law before.***
