

The following letter was written by Me, Nha-phatkamon Noo-phakdee, The Daughter of The God and The Only One Latest Prophet of the current millennium who am being detained in Thailand. I would like the attorney team of Prince Andrew of The British monarchy to give the following letter to the judge and the jury who judge the case of Prince Andrew and Virginia Giuffre to consider.

Judge and jury, sir.
