

## ***Some evil plans of pimp king Bhumibol***

*(I wrote these truths from 26 July 2022 to 28 July 2022, posted them on My website on 28 July 2022, and corrected them again for this book.)*

**I have told everyone many times “The God truly wants to teach everyone “One *must be responsible* for his mind, his word, and his action. You *must not think no one knows as at least*, The God, all gods, all goddesses, and *you yourself know!*””. Nevertheless, The God has told Me to tell you “Pimp king Bhumibol has told Prayuth Jun-o-cha “I and my family are “ICONS” of Thailand, so *we cannot accept our guilts. Thus, the Thai army must accept the guilts instead of us!*””**

*Have you ever listened to the song “Take A Bow (Main)” sung by Rihanna? Some pronunciations that I heard from the song are that;*

*“Oh, “Andy” are what for **the best lie***

*Goes to you (goes to you)*

*For making me believe*

*That you could be*

*Faithful to me*

*That’s “hear” (pronounced the same as “here”) your speech out”*

**The God told Me ““Andy” is “Prayuth Jun-o-cha”. “Andy” was a secret code of Prayuth which he used for his soldier missions”.**

We have many pieces of evidence and many witnesses to prove to *every Thai court* “Some Thai government officers have been henchmen of Queen Elizabeth and The British Monarchy to overthrow the Chakri dynasty!””.** **And pimp king Bhumibol, the satanic Chakri dynasty, and high-level Thai soldiers *have planned* to let some Thai soldiers *to lie to everyone* “We have worked with Queen Elizabeth and The British Monarchy together to overthrow the Chakri dynasty. We are henchmen of Queen Elizabeth and The British Monarchy!” too.**

Their plans in the paragraphs above are *important reasons why pimp king Bhumibol and the satanic Chakri dynasty did not let Me go out of Thailand to the US with Barack Obama at the end of 2012. If they let Me go with Barack and they still continued severe tormenting Me, I would have the right to proceed My cases to the US court. I mean that they really know how different between justice process of the US and justice process of Thailand are. And after I will have sued them, they will request a judge to consider “territory principle of criminal law” before the judge will judge the cases. ...*

... Do you know *in Thailand*, people who have “power” or “money” can “order” Thai police officers to make “fake evidences” to change “right” to be “wrong” and “wrong” to be “right”, and in Thailand, “power” or “money” can “launder a crime and a felony”? I mean that if you live your life in Thailand and you have “power” or “lots of money”, you will have scores of “partisans”, and you can do anything even commit crimes and felonies. As a consequence, *pimp king Bhumibol and the satanic Chakri dynasty genuinely want the crimes and the felonies they have committed to Me “to happen in Thailand” “to be investigated in Thailand” so as to “order” Thai government officers who are their henchmen to “blacken” and “overthrow” Queen Elizabeth, Prince William, and The British Monarchy too!*

**The other truths about the laws of Thailand which I would like you all to know are;**

1) If a person provokes his target, but the person does not start to attack and/or injure the target, and the target starts to damn the person, *the courts will tend to judge “The target committed “defamation””.*

2) If a person provokes his target, but the person does not start to attack and/or injure the target, and the target starts to attack and/or injure the person, *the courts will tend to judge “The target committed “bodily harm””.*

*I mean that a person or a group that start attacking his opponent first will be convicted of crime.*

3) If a person starts to attack and/or harm his target, and the target reacts the same to the person, *the courts will tend to judge “Both of them have voluntarily joined the quarrel, so the criminal law does not protect both of them”.*

4) If a person hurts, and/or injures his target, but the target just gets bruises on his face and/or body, *the person will be only fined.*

5) To report to Thai police officers to charge a person who tends to **harm, hurt, injure, or kill** an innocent person, the innocent person or a witness **must have** “a voice record” and/or “a video clip” **to show that the person “really did” the crime.** *If the innocent person and/or the witness does not have “any voice records” or “any video clips” to show to the Thai police officers, the Thai police officers cannot charge the person in that the Thai police officers are afraid that the courts will judge “The police officers violated human right of the person!”*

**I mean that an innocent person had to be harmed, hurt, injured, or killed before Thai police officers can charge a criminal!**

6) Most of Thai laws especially technical laws were legislated for Thai government officers to do corruptions easily.

7) Whether the Thai king is good or bad, it was written in article 6 of the constitution of Thailand **“The king is in the revered position. Nobody can violate the king. No matter what happen, nobody can accuse or sue the king”**

8) Whether the Thai king and the Thai dynasty are good or bad, it was written in article 112 of criminal law of Thailand **“One who defames, disdains, or shows malevolent malice against the king, the queen, heir apparent, or the regent, will be prisoned 3 years to 15 years”**

**You will understand justice process of Thailand if you know that “Blue Diamond” which is a diamond of The Saudi Arabian Monarchy has been in possession of prostitute queen Sirikit and the satanic Chakri dynasty, if you know that pimp king Bhumibol and the satanic Chakri dynasty were instigators of well-known shooting “Sondhi Limthongkul” in 2009, and if you know that why “Vorayuth Yoovidhya” who is a descendant of “Red Bull” can continue spending his luxury life abroad after he had taken drugs and drove a car to crash a policeman, and the policeman immediately died at the crime place. ...**
