

The truths of consultants

(I wrote this script and posted it on My website on 23 May 2023, but updated it from 24 May 2023 to 25 May 2023 and posted it on My website again on 25 May 2023.)

I would like to send My message in these video clips to King Charles, Prince William, and Prince Harry.
