Revenues from sales and service income for Q3/2022 was Baht 1,305.85 million, increased from the same quarter of the prior year Baht 305.37 million or 30.52% due the new products launched, iPhone Series 14, in mid-Q3/2022 while iPhone Series 13 launched in Q4/2021.

Gross Profit

Gross profit for Q3/2022 was Baht 144.89 million, increased from the same quarter of the prior year Baht 45.66 million or 46.02%. The gross profit margin for Q3/2022 is approximately 11.10% compared with the same quarter of the prior year at 9.92%. The increase in gross profit margin was mainly due to the well-managed in cost of sales and higher in sales proportion of Non-Apple products.

Selling and administrative expenses

Selling and administrative expenses for Q3/2022 was Baht 120.21 million, increased from the same quarter of the prior year Baht 32.21 million or 36.60%. The proportion of selling and administrative expenses compared with total revenues is approximately 9.11% compared with the same quarter of the prior year at 8.72%. The increase was mainly due to the rental and personnel expenses from stores expansion. Moreover, selling and credit card expenses increased in line with increasing in revenues.

Net Profit

Net profit for Q3/2022 was Baht 29.08 million, increased from the same quarter of the prior year Baht 14.69 million or 102.14%. The net profit margin for Q3/2022 is approximately 2.20% compared with the same quarter of the prior year at 1.43%. The increase mainly due to the increased in sales growth and the well-managed in expenses.
