# 7. Payment Method

Payment of the amount specified in the Exercise Notice (the Warrant Holder can obtain the subscription form at the Company and on the Company's website <a href="www.tgpro.co.th">www.tgpro.co.th</a>). The Warrant Holders who wish to exercise the rights to purchase the ordinary shares shall make the payment according to the amount specified in the form to exercise the Warrants as follow:
