



Announcement of Nongkhaem Police Station Anti-Bribery Policy and No Gift Policy for performing duties.

According to Section 128 of the Organic Act on Counter Corruption B.E. In addition to assets or benefits that are legitimate by laws, rules or regulations issued by virtue of the provisions of the law. Unless accepting property or any other benefits morally in accordance with the rules and amount prescribed by the National Anti-Corruption Commission. According to the Code of Ethics of Police Officers BE. 2021 Clause 2 (2) Honesty perform legal duties Regulations of the Royal Thai Police. To be a standard of practice and values for police officers Nongkhaem Police Station To comply with laws, rules, regulations and other regulations. with the determination to lead the agency to carry out tasks Will perform duties and manage the police station with honesty, transparency and in accordance with good governance. in accordance with the value that "fairness that can be touched"

Nongkhaem Police Station Establish an anti-bribery policy (Anti-Bribery Policy) and the policy of not accepting all kinds of gifts and premiums (No Gift Policy) from performing duties. The details are as follows.

1. Objective

1 . To prevent or reduce the chance of accepting bribes, gifts, tokens or any other benefits. for police officers at Nongkhaem Police Station.

2 . For the operation of Nongkhaem Police Station to be transparent fair without corruption and in accordance with the principles of law and good governance.

3. To raise awareness and create organizational culture for police officers Nongkhaem Police Station strictly adhere to by not seeking, receiving and giving gifts, tokens or any other benefits from performing duties to avoid actions that may affect discretion or decision which may lead to discrimination or cause a conflict of interest.

2. Definition

“ Performance of duty” means an act or performance of duty by a government official in an appointed position. or has been entrusted to perform any duty or to act on behalf of one of the duties both in general and in particular as police officers whose powers and duties are defined by law Or it is an act according to the powers and duties prescribed by law to be the powers and duties of the police.

“ Bribe” means property or other benefits given to a person in order for that person to act or refrain from acting as desired by the payer of bribes.

“ Gifts, gratuities or any other benefits that affect the performance of duties” means anything that has value other than money. given to employees that affect decision-making, approval, permission, or any other acts that affect the performance of duties in a manner that facilitates dishonest benefits to the gift giver in the past, while accepting, or during future.

3. Scope of application

Announcement of Nongkhaem Police Station on Anti-Bribery Policy (Anti-Bribery Policy) and the policy of not accepting all kinds of gifts and premiums (No Gift Policy) from performing duties. This edition shall apply to All police officers of Nongkhaem Police Station.

4. Regulation

1. Must show gestures or words that show intention not to accept or give gifts.
2. Do not consent or concur with personnel in the agency, family member or related persons requesting, accepting gifts, tokens or any other benefits from persons involved or having stakes in the performance of duties.
3. . Must not seek, accept or give gifts of any kind from performing duties. to avoid actions that affect discretion or decision making which has the effect of discrimination or conflicts of interest.
4. . Police officers, Nongkhaem Metropolitan Police Station have a duty to notify such policies to third parties for their acknowledgment.

5. If an offender is found, inform the supervisor immediately.

5. Monitoring

Commander Responsible for supervising, supervising, monitoring and inspecting police officers under affiliation. Nongkhaem Police Station Follow this announcement If any violator is found, report to the station chief as soon as possible.

6. Policy Violations / Penalties

If an offense is found / there is a complaint Report clues about wrongdoing caused by personnel Nongkhaem Police Station will investigate the facts as soon as possible and carry out process steps and report the progress to the complainant And if found to be a criminal offense, criminal proceedings will be taken. If it's a disciplinary offense Follow the steps and then punish accordingly relevant regulations and then report.

7. Complaints

8. Complainant Protection

1 . Upon being notified of the preliminary corruption information to be treated as a government secret to conceal the name, last name or any other information that identifies the complainant / whistleblower and conduct a confidential investigation. Whether or not the story is true or not.

2 . If the information received has been verified is beneficial to the government, The informer has the right to receive a favor such as a certificate of honor.
