4.1. Description of first aid measures**In the event of splashes or contact with eyes :**

Wash thoroughly with fresh, clean water for 15 minutes holding the eyelids open.

Remove contaminated clothing and wash the skin thoroughly with soap and water or a recognised cleaner.

Watch out for any remaining product between skin and clothing, watches, shoes, etc.

In the event of swallowing :

Do not give the patient anything orally.
