Extinguishing Media Recommendations

Effective Date: 13/3/20

Recommended: alcohol resistant foam, CO2, powders, water spray. Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard. Appropriate breathing apparatus may be required. Cool closed containers exposed to fire with water. Do not release runoff from fire to sewers or waterways.

SECTION 6 – ACCIDENTAL RELEASE MEASURES
